



#### ADCA Policy on Gifts & Bequests

The Antique Doorknob Collectors of America (ADCA) is incorporated as a non-profit organization dedicated to the study and preservation of ornamental hardware. Since ADCA has been qualified as a tax-exempt entity [section 501(c)(3) of the IRS Code], gifts and donation made to ADCA are in general tax deductible to the donor. ADCA will provide donors with appropriate written acknowledgements of all gifts in excess of \$250.

ADCA proposes to use gifts and bequests to achieve the ADCA mission of preserving ornamental hardware and educating the public about the history of the hardware industry in America and about the design and function of such hardware.

Examples of ADCA activities that promote its mission include:

- Regular publishing of a newsletter about antique hardware and the activities of the ADCA and its members.
- Maintaining archival materials relating to the history of the hardware industry, and making copies of such materials available to the public.
- Maintaining an internet website to educate the public about ADCA and antique hardware, and responding to hardware questions posed by the public who visit the website.
- Hosting an annual convention where ADCA members and the public can gather to see and learn about antique hardware.
- Encouraging and facilitating the creation of public displays of antique hardware in appropriate public facilities, such as libraries and museums.
- Supporting the publication of books and articles related to antique hardware and the hardware industry

Gifts and bequests given by the donor without restriction will be used by ADCA under the direction of the ADCA Board, to support and promote activities such as those listed above. Gifts and bequests given with donor designated limitations will be accepted by ADCA if ADCA feels it can comply with the wishes of the donor, and once accepted the funds will be expended according to the limitation imposed by the donor. Donors should make unrestricted gifts by stating that the gift is being made to the "Antique Doorknob Collectors of America."

ADCA does not currently manage endowment funds, but ADCA will manage any endowment type of gift or bequest so as to preserve the corpus of the assets given and manage the assets so as to provide perpetual income for ADCA activities such as those listed above. Such endowment assets shall be considered "permanently restricted".

#### A Brief History of ADCA

The Antique Doorknob was published in 1976. The decades of 1950-1970 witnessed the often sad phenomenon known as urban renewal. Aging Victorian houses were destroyed to make way for modern city dwellings. With luck salvage minded opportunists arrived before the wrecker's ball and bulldozer. Ornate hardware plucked from the ruins made its way to the hands and hearts of collectors, one of whom was a shy and reserved beauty operator from Tillamook named Maud Eastwood. Not satisfied with merely owning a collection of salvaged doorknobs, Maud was driven by a need to learn. A true scholar emerged, and the hobby of doorknob collecting would never be the same.

Maud traveled, scoured libraries and patent documents, talked with collectors, historians, artisans—anyone who might provide knowledge about the whys and wherefores of door knob history.



We are truly thankful that Maud then made an even greater commitment, embarking to share the fruits of her research with others. The result was a book, The Antique Doorknob or "TAD" for short — a remarkable achievement. National publications such as The Old House Journal mentioned TAD with praise, and suddenly Maud was contacted from near and far by kindred souls who had succumbed to the strange compulsion to collect old hardware.

#### A Brief History of ADCA (cont)

1977 saw the publication of a newsletter, The Antique Doorknob. It wasn't long before the knobbers clamored to form an organization, and small groups of collectors began to meet. By 1981 things were heating up. Arnie Fredrick brought the pot to a boil with an offer to host a meeting of doorknob collectors from around the country.

The first "convention" was held in Waverly Iowa in September, 1981, and those attending agreed to the formation of The Antique Doorknob Collectors of America, or ADCA

Bylaws were drafted, the club formally "incorporated" and ADCA was granted official status as a non-profit entity.

By the end of 1981, 43 members had joined, growing to 100 in 1985 and to 200 active members in 1990. By year 2000 over 500 people had joined ADCA, with over 250 remaining as active duespaying members.

For simplicity sake this account largely omits the names of those who played key roles in the early years of the club's formation, but it took the dedicated efforts of many individuals to achieve success. Please read the accompanying ADCA chronology to learn about some of those who participated and the part each played. Early members not mentioned take equal pride in contributing to the birth of ADCA.



Joseph B. Sargent

In 1810, the Sargent family entered the hardware business, beginning the trail that eventually led to the present SARGENT Manufacturing Company.

**Sargent and Company** was a manufacturer of locks and hardware, with headquarters in New Haven, Connecticut. It was founded by Joseph B. Sargent, who was born in Leicester, Massachusetts, in 1822. Sargent and Company acted as sole agent for Mallory, Wheeler & Company, a manufacturer of

locks and builders' hardware. After losing this lucrative account, Joseph Sargent began manufacturing his own locks and builders' hardware.







**P.E. Guerin** is advertised as the oldest decorative hardware firm in the United States, and the only metal foundry in New York City. The company was started in 1857 by French immigrant Pierre Emmanuel Guerin and has been at its current location on Jane Street in Greenwich Village since 1892.

**Pierre Emmanuel Guerin** was one of the Pioneers in artistic metalwork in New York City, and examples of his production can still be found in various public buildings, parks and important residences throughout the city and the country.



#### THE P. & F. CORBIN CORPORATION

**P. & F. Corbin** originated in 1849 when brothers Philip and Frank Corbin, and Edward Doen established the firm of Doen, Corbin & Co., to manufacture ox balls. The company's name changed to P. & F. Corbin in 1851. In the last half of the 19th century they broadened their products to include coffin trimmings, knobs, and stove handles. In 1858, Andrew Corbin became identified with the company and took an active part in the conduct of its affairs. In 1868 they began specializing in the manufacture of builder's hardware and locks.











The Russell & Erwin Manufacturing Company originated in 1839 when Henry E. Russell, Cornelius B. Erwin, and Frederick T. Stanley formed a partnership to produce locks and builders' hardware, under the name of Stanley, Russell & Company. When Mr. Stanley withdrew from the partnership in 1840, Smith Matteson and John H. Bowen were added, changing the name of the company to Matteson, Russell & Company. In 1846, with the death of Mr. Matteson and the expiration of the partnership terms, the company's name changed to Russell & Erwin. In 1851 the partnership was reorganized as a joint stock company and was from that time known as Russell & Erwin Manufacturing Company, until its merger with P.& F. Corbin in 1902.



#### THE YALE & TOWNE MANUFACTURING COMPANY



Yale & Towne Manufacturing Company was established in 1868 by Linus Yale and Henry Towne in Stamford, Connecticut. Linus Yale, Jr. was born in Salisbury, New York. Yale's father, Linus Yale, Sr., opened a lock shop in the 1840s in Newport, New York, specializing in bank locks. His son joined him in the business in 1850, and introduced some combination safe locks and key-operated cylinder locks around 1862.

ness opportunity and had become impressed about the possibilities of Yale's new cylinder" lock. In October of 1868, the two men formed the Yale Lock Manufacturing Co., to be located in Stamford, Connecticut. Towne provided new capital and management of the firm, and Yale the invention. Yale died later in 1868, and Towne reorganized the company as Yale & Towne Manufacturing Co..

#### ADCA Bylaws

#### **ARTICLE I – OFFICES**

<u>Section 1</u>. The principal office of the Corporation in the State of Iowa shall be located at 587 Somerset Lane, Iowa City, Johnson County, Iowa 52240 (REV. 8/95).

Section 2. The registered office of the Corporation required by the Iowa Non-profit Corporation Act to be maintained in the State of Iowa may be, but need not be, identical with the principal office in the State of Iowa, and the address of the registered office may be changed from time to time by the Board of Directors.

#### **ARTICLE II - MEMBERS**

Section 1. Class of Members. There shall be one class of members.

Section 2. Eligibility of Members. Anyone interested in antique doorknobs and related hardware is eligible to become a member with full voting rights and other privileges. However, any two or more family members applying for membership and living at the same address shall collectively be one member unless more than one family member at the same address pays the annual dues. In that event, each member at the same address and paying dues will be a member.

Section 3. Member dues. The annual dues required for membership shall be determined by the vote of the members. Dues may vary from year to year, but dues shall be the same for all members. Any member failing to pay dues within 90 days of January 1 of each year shall be automatically dropped from membership. (REV. 9/89).

Section 4. Annual Meeting. There shall be an annual meeting of members for the transacting of such business as may come before the meeting and for conducting annual elections. This meeting is to be held during the months of July to September of each year, unless otherwise ordered by the Board of Directors. Notice of the annual meeting, issued by the secretary, shall be mailed to the last recorded address of each member at least 30 days before the annual meeting.

Section 5. Special Meetings. Special meeting of the members may be called by the President or by the Board of Directors. A special meeting of the members may be called by members having one-fourth (1/4) of the votes entitled to be cast at such a meeting. Notice of a special meeting, issued by the secretary, shall be mailed to the last recorded address of each member. No business other than that specified in the

notice of the special meeting shall be transacted.

<u>Section 6.</u> Quorum of Members. Members holding 10% of the votes entitled to be cast on the matter to be voted upon, represented in person or by proxy, shall constitute a quorum.

<u>Section 7</u>. **Voting of Members.** Each member shall be entitled to one vote upon each item submitted to vote at a meeting of the members.

<u>Section 8. Lifetime Membership.</u> The Board may grant a lifetime membership to a person judged to have made outstanding contributions to the Corporation and or to the field of antique doorknob collecting. From time to time the Board may authorize the availability of the purchase of a lifetime membership subscription.

#### ARTICLE III - BOARD OF DIRECTORS

<u>Section 1</u>. General Powers. The business and affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors may authorize any officer or officers, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation.

Section 2. Number and Election of Directors. The elected Board of Directors, excluding any emeritus position(s), shall consist of a minimum of ten (10) and a maximum of fourteen (14), who shall serve two years terms. One half of the directors shall have terms commencing in alternate years, and shall be elected at an annual election of the membership, by a majority of votes cast at such an election. Such directors shall start serving immediately after election and serve thereafter until their successors are elected and qualified. The Board, by a majority vote of those present, may appoint Directors to fill existing vacancies.

Section 3. Emeritus Director(s). In addition to the elected Directors, there shall be a category known as "Emeritus Director". Election to the position of Emeritus Director shall be considered for unique individuals who have made extraordinary contributions to the welfare of the Antique Doorknob Collectors of America; shall require majority vote of the Board of Directors and confirmation by a majority of members voting at an Annual Meeting; and shall include full Director voting rights and eligibility to hold office.

Section 4. Vacancies. If the office of any director shall become va-

cant between annual meetings by reason of death or resignation, a successor may be appointed by the remaining members of the Board of Directors to fill the vacancy until the next regular meeting of the Board of Directors. A special meeting of the members may be called to fill the vacancy if the Board of Directors so desires.

<u>Section 5</u>. Regular Meetings. A regular meeting of the Board of Directors shall be held during the five day period preceding the annual meeting of members, without other notice than this bylaw. At the discretion of the President, or by a majority vote of the Board of Directors, a second regular meeting may be held immediately after, and at the same place as the annual meeting of members, without other notice than this bylaw.

<u>Section 6.</u> Special Meetings. Special meetings of the Board of Directors may be called by or at the request of the President or any Director, who may fix any place and time therefore. Notice shall be given by personal notification to each Director.

<u>Section 7.</u> **Quorum.** A majority of the currently serving Directors shall constitute a quorum for the transaction of business at any meeting of the Board of Directors.

<u>Section 8.</u> Manner of Acting. The act of the majority of Directors present at a meeting at which a quorum is present shall be the act of the Board of Directors, except to the extent provided in the Articles of Incorporation and in these Bylaws.

Section 9. Informal Action by Directors. Any action required by the Iowa Nonprofit Corporation Act, to be taken at a meeting of the Directors of the Corporation, or any action which may be taken at a meeting of the Directors, may be taken without a meeting, if a consent in writing setting forth the action so taken is signed by all of the Directors.

#### ARTICLE IV - OFFICERS

<u>Section 1</u>. Number. The Corporation shall have a President, Vice President, Secretary, Treasurer, and other such officers as may be deemed necessary. Any two or more offices may be held by the same person.

<u>Section 2</u>. Election and Term of Office. The officers of the Corporation shall be elected each year at the annual meeting of members by a majority of votes cast at such election. Officers shall hold office for one

year, and may succeed themselves, except that no person shall serve as President for more than four successive terms. Election or appointment of an officer or agent shall not of itself create contract rights. (REV. 10/93).

Section 3. Vacancies. A vacancy in any office because of death, resignation, removal, disqualification, or otherwise, may be filled by the Board of Directors for the remaining portion of the term.

Section 4. President. The President shall be the principal elected officer of the Corporation and subject to the control of the Board of Directors, shall supervise and control all of the business and affairs of the Corporation. The President shall preside at all meetings of the members, and shall cause to be called regular meeting of the members in accordance with these Bylaws. The President, subject to the approval of the Board of Directors, shall appoint and remove, employ and discharge, and fix the compensation of all agents and employees of this Corporation other than officers appointed by the Board of Directors. The President shall make and sign all contracts and agreements in the name of this Corporation which are authorized by the Board of Directors unless the Bylaws provide that the Secretary shall also sign said documents.

Section 5. Vice President. In the absence of the President or in the event of President's inability to act, the Vice President shall perform the duties of President, and when so acting, shall have all of the powers and be subject to all of the restrictions upon the President. Any Vice President shall perform such other duties as from time to time may be assigned to the office by the President of by the Board of Directors.

Section 6. Secretary. The Secretary shall see that all notices are duly given in accordance with the provision of the Bylaws or as required by law; be custodian of the corporate records, and of all documents, the execution of which on behalf of the Corporation is duly authorized in accordance with the provisions of these Bylaws; keep a register of the post office address of each member which shall be furnished by each member, and in general perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned to the office by the President or by the Board of Directors.

**Section 7. Treasurer.** If required by the Board of Directors, the treasurer shall give a bond for the faithful discharge of duties, in such sum and with such sureties as the Board of Directors shall determine. The Treasurer shall have charge and custody of, and be responsible for, all funds and securities of the Corporation; receive and give receipts for

monies due and payable to the Corporation; and deposit all such monies in the name of the Corporation in such banks, trust companies, or other depositories as shall be selected in accordance with the provisions of Article V of these Bylaws. The Treasurer shall in general perform all duties incident to the office of Treasurer and such other duties as from time to time may be assigned to the Treasurer by the President or by the Board of Directors. It is the responsibility of the Treasurer to keep a record of all club property. (REV. 9/86)

#### ARTICLE V - WRITTEN INSTRUMENTS

<u>Section 1</u>. Contracts. The Board of Directors may authorize any officer or officers, agent or agents, to enter into any contract of execute and deliver any instrument in the name of and on behalf of the Corporation, and such authority may be general or confined to specific instances.

<u>Section 2.</u> Loans. No loans shall be contracted on behalf of the Corporation and no evidence of indebtedness shall be issued in its name unless authorized by a resolution of the Board of Directors. Such authority may be general or confined to specific instances.

Section 3. Checks, Drafts, etc. All checks, drafts, or other orders for the payment of money, notes, or other evidence of indebtedness issued in the name of the corporation, shall be signed by such officer or officers of the Corporation or in such manner as shall from time to time be determined by resolution of the Board of Directors.

<u>Section 4.</u> Deposits. All funds of the Corporation not otherwise employed shall be deposited from time to time to the credit of the Corporation in such banks, trust companies, or other depositories as the Board of Directors may select.

#### ARTICLE VI - OTHER PROVISIONS

Section 1. Fiscal year. The fiscal year of the Corporation shall begin on January 1 and end on December 31 in each year. (REV. 9/89)

Section 2. Waiver of notice. Whenever notice is required to be given to any member or Director of the Corporation under the provisions of the Iowa Nonprofit Corporation Act or under the provisions of the Articles of Incorporation or the Bylaws of the Corporation, a waiver thereof in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be equivalent to the giving of such notice.

#### ARTICLE VII - DISSOLUTION

The Corporation may be dissolved only on the affirmative vote of a 2/3 majority of the entire membership, as determined through a written ballot. In the event of such dissolution, all assets shall be converted into cash, excepting real estate, equipment, and other fixed assets suitable for transfer to a museum or similar institution. After payment of all outstanding indebtedness, the assets of the Corporation shall be distributed to any worthy 501(c.)3 organization chosen by vote of the Board and approved by vote of the members at an Annual Meeting of the Corporation. This shall not be construed to mean that distribution shall be limited to one such organization, but only that such organizations must be non-profit and exempt under 501(c.)3.

#### ARTICLE VIII - AMENDMENTS OF BYLAWS

**Section 1.** These Bylaws may be altered, amended, or repealed and new Bylaws may be adopted by the Board of Directors at any regular or special meeting of the Board of Directors.

#### Notes:

- From 1981 until 1985, principle office was in Waverly, Iowa, home of founder Arnold Frederick.
- 2. ADCA does not have "sustaining", "supporting", or "inactive" classes of membership.
- 3. Previous By-laws allowed for purchase of a lifetime membership.
- 4. Lifetime memberships have been granted to Maude Eastwood and Len Blumin.
- 5. Originally, the number of Directors was set at eight (8), term was one year, and elections were held annually.
- 6. Maude Eastwood was granted a lifetime position on the Board in 1983, and was subsequently honored by being elected Emeritus Director.
- 7. The "second" meeting used to be required for the Board to elect officers (see footnote 8 below).
- 8. Officers were previously elected by the ADCA Board rather than by ADCA members.
- 9. Previous versions of the Bylaws did not contain any statement about dissolution of the corporation.
